Contributory arrangements of the IGHM

1. The annual contribution fee will be withdrawn from your bank account by direct debit around February 15th each year, or at the beginning of the membership. The direct debit authorization is an integral part of the membership application overleaf.
2. Payment by direct debit is available for inhabitants of SEPA countries only. For non-SEPA countries, individual payment conditions will be agreed upon at the beginning of the membership.
3. Costs (chargeback) in the event of insufficient funds in the account or closure of the account are to be paid by the member.
4. If the direct debit for the annual contribution is unsuccessful or cancelled due to lack of funds in your account, shipment of the IGHM magazine will be postponed, and any possible collection costs will have to be paid by the member.
5. If a member should end his/her membership during a current year, no contribution will be refunded for the remaining period of that year.
6. If a membership begins on or before June 30th, the full contribution for that year is payable. Memberships beginning between July 1st and December 31st only pay half of that. Membership begins as soon as the first contribution is payed.
7. Former members can only then become a member again after any overdue payments are settled, and if a majority of the board agrees on him / her rejoining IGHM.
8. The annual membership fee will be determined at the annual membership meeting.
9. Cancellation of the membership has to be done in writing to the chairman by November 15th of the respective year.
